Information Technology Services at Lafayette

Technology plays a critical role at Lafayette, from streamlining business processes to innovating teaching and research practices. The <u>technology strategy</u> provides a guide, ensuring that resources are well-aligned to advance the College's strategic direction. Whether deploying custom, open-source solutions, or best-of-breed cloud technologies, ITS is committed to a hybrid approach that best supports the community.

ITS is composed of five units—Application and Integration Development, IT Infrastructure and Cybersecurity, ITS Operations, Learning and Research Technologies, and User Services. Across these teams, ITS employs 38 professionals. For FY2025, ITS' budget included \$3.9M in operating expenses and \$4.9M in compensation and benefits.

Teaching, Learning, and Research resources managed by ITS include more than 200 smart classrooms across campus with installed presentation technology ranging from simple displays to smart classrooms with touch panel control systems to collaborative labs and media creation studios, including Pardee 28, a dual-purpose, collaborative computer classroom. ITS maintains Moodle as the campus's course management system; WordPress to host personal, club, and organization home pages; Panopto for streaming media creation and hosting platform for course related content as well as publicly available content; and many tools to support remote teaching and learning, including Google Workspace and AWS AppStream.

Research and High-Performance Computing (R/HPC) at Lafayette is an ecosystem of services facilitating research and pedagogical projects and the team delivers and supports a suite of hardware, web-based, virtualized, and consultation services targeted at relevant research and teaching use cases, which often necessitate specialized computational hardware and software platforms, environments, and capabilities.

ITS helps ensure the confidentiality, integrity, and availability of College data and systems through a comprehensive information security program and related services. The information security program includes providing policy, guidelines, and educational materials about protecting computing resources and sensitive data, information security risk assessment, vulnerability management, and computer security incident response and resolution. Application and Integration Development supports the College's web infrastructure and integration between platforms. ITS in collaboration with various College offices provides access and support for services that enhance operational efficiency.

Peer Units

In addition to management of the ITS organization, the CIO will collaborate with the leaders of other units on campus to strategically meet their IT needs, including the following.

The <u>Lafayette Library</u> was awarded the 2014 Excellence in Academic Libraries award from the Association of College and Research Libraries (ACRL). The award highlights the library's commitment to digital scholarship, its pioneering of new models for collaborative content acquisition, and the impact of its Information Literacy and Special Collections programs on student learning. The David Bishop Skillman Library is the College's main library, with a collection of more



than 600,000 volumes. The Fred Morgan Kirby Library has an additional 30,000 volumes related to government and law. The two libraries subscribe to thousands of magazines, journals, and newspapers in electronic and paper formats and an extensive array of electronic databases and books, accessible both on and off campus. The Lafayette College Special Collections and College Archives collection is available for student research and features especially strong holdings relating to the Marquis de Lafayette, Stephen Crane, and angling.

The <u>Registrar's Office</u> maintains the integrity and security of permanent academic records in accordance with the Family Educational Rights and Privacy Act of 1974 (FERPA) and upholds Lafayette College academic policies, procedures, and guidelines. Lafayette maintains its student records via Banner.

The Opportunity

The CIO will report to the Executive Vice President for Finance and Administration and will fulfill management and mentoring responsibilities that provide equitable and inclusive working environments to the staff they supervise and the faculty, staff, and students they work with. They will provide leadership across IT functions, supporting their ongoing collaboration and ensuring their unique needs are addressed within a strategic vision of the College's information and technology resources.

The CIO will function as an integral part of the senior staff, ensuring that technology investments and priorities align with overall institutional goals, contributing to effective decision-making by the leadership team, and bringing a clear grasp of the College's opportunities, risks, and challenges to the leadership and staff of ITS. They will be responsible for building strong and productive relationships with academic and administrative leaders and their staff and for communicating with and advising departments across campus to provide efficient and effective digital solutions for the College.

The CIO is responsible for 6 direct reports:

- Executive Director, ITS Operations
- Director, IT Infrastructure and Cybersecurity
- Director, User Services
- Director, Learning & Research Technologies
- Director, Application & Integration Development
- Administrative Operations Coordinator

Core Responsibilities:

- Foster an environment that champions innovation, exceptional service, and results-driven accountability aligned with the institution's core mission and strategic objectives.
- Build and mentor a high-performing ITS team through targeted professional development, thoughtful supervision, performance assessment, and career growth opportunities that establish productive working relationships throughout the campus community.
- Align technology investments with institutional priorities by developing and deploying information resources that directly support the College's long-term plan.



- Assess and communicate technology-related risks and opportunities to College stakeholders while implementing robust security protocols to safeguard institutional data assets.
- Direct comprehensive oversight of enterprise technology systems including network infrastructure, academic platforms, administrative applications, web services, telecommunications, and technical support in collaboration with campus departments to meet both academic and operational needs.
- Design, implement, and regularly review comprehensive systems for data security, risk management, disaster recovery, and business continuity planning.
- Guide policy development for data privacy and research information protection while establishing and maintaining campus-wide cybersecurity awareness and training programs.
- Execute ongoing evaluation and oversight of academic and administrative systems to confirm alignment with institutional and departmental objectives.
- Continuously adapt and refine the institution's technology roadmap to anticipate and respond to evolving campus community requirements within the framework of the College's strategic vision.
- Ensure fiscal responsibility through effective budget development and management for all ITS operations.
- Prioritize and establish realistic timelines for technology initiatives, presenting recommendations to senior administration and governance bodies.

Strategic Priorities for the incoming CIO:

- Modernize IT Infrastructure & Systems Lead a comprehensive review of existing systems including Banner ERP optimization, Wi-Fi connectivity improvements across campus, and streamlined technology lifecycle management to assess integration improvements (65+ Banner integrations, 160+ campus systems).
- **Establish Data-Driven Decision Culture** Develop analytics capabilities and data utilization practices across departments, breaking down information silos to enable better insights and reporting while addressing the need for more data strategy.
- Implement Effective IT Governance Create a formalized project prioritization framework and cross-departmental technology committees to ensure strategic alignment, resource optimization, and transparent decision-making processes.
- Solidify IT's Role as a Strategic Partner Strengthen IT's position as a strategic partner through clear communication, visible campus engagement, and demonstrated value to the institution
- **Lead Cultural Transformation** Guide the institution through digital change management by focusing on training, adoption, and collaborative relationships to leverage the "unique moment with new leaders" while addressing questions and concerns around technology innovation.

- Dedication to the mission of Lafayette College excellence in undergraduate education and engagement in a transformative educational experience that bridges the liberal arts, engineering, and interdisciplinary study, and fosters intellectual inquiry, artistic exploration, scholarship, and personal growth in a vibrant, diverse, and inclusive community.
- The ability to maintain an institutional and strategic perspective while helping staff to prioritize and manage shorter-term activities.
- Experience in developing a vision and plans for future technologies and capabilities, including business cases for strategic and sustainable technology investments.
- Experience mapping business requirements to IT architecture and strategy.
